<b>Task</b> 1.0	Rate	Qty	%	Amount
Contain area for remediation by the hatch of the crawlspace (Containment eliminates any contaminates from existing into the livable space. Without the containment also the insulation, if removed can possibly enter the livable space, kicking insulation, dirt and possible mold-like substance around. We can pull the containment after remediation has taken place. Cost is relayed on a linear foot basis)	\$32	16	0%	\$512
<b>Task</b> 2.0	Rate	Qty	%	Amount
Run air scrubber (An air scrubber is designed with a dual filtered system in an arear to eliminate any possible contaminates from going through the home. The air scrubber is ran on a daily based per the whole duration of the job.)	\$75	5	0%	\$375
<b>Task</b> 3.0	Rate	Qty	%	Amount
Dry ice blast (Dry ice blasting is used to eliminate growth on a surface areas that needs a higher abrasion technique. The dry ice blaster will freeze the growth (killing it) with dry ice rice pellets. Also this technique pulls a thin layer off the surface area that is used to strip paints, dirt and growth off any and all surface areas. This is a per square foot cost.)	\$3.75	1615	0%	\$6,056.25
<b>Task</b> 4.0	Rate	Qty	%	Amount
PPE (Personal Protective Equipment) (This is safety equipment for our techs to wear during remediation practices. This is a per person per day basis. There will need to be new PPE every day for proper safety. This includes the Tyvek suits, gloves, and any filters per the duration of the job).	\$75	6	0%	\$450
<b>Task</b> 5.0	Rate	Qty	%	Amount
HEPA vacuuming in crawlspace (HEPA vacuuming is a process of pulling all contaminates off a surface area. This process eliminates mold particles from a surface area with specific vacuums without contaminating the air quality of a livable space. HEPA vacuuming is normally done before and after to reassure no particles are in the space that was contaminated).	\$1.10	1615	0%	\$1,776.50

crawlspace (The removal of vapor barrier can be				
done for two reasons, one is that the vapor				
barrier is contaminated by the growth. Any				
building supplies is deemed contaminated when				
the contamination in an area is over				
10sqft. Another reason to replace vapor barrier				
is that the vapor barrier is not installed properly.				
Improper install of vapor barrier can cause				
moisture issues which in turn can cause				
potential growth in the future. This done on a per				
sqft. basis).

Pour approximately 16ft. x 2ft. of concrete in the bottom of the flower bed to reassure that water will not continue to seep through the floor bed. (There will need to be road mix placed in the flower bed after the rocks are removed. Then the road mix will be compacted and then concrete poured).	\$16	32		\$512
